### MEETING MINUTES

May 7, 2019 Regular Meeting

The Grady County Board of Commissioners met on May 7, 2019 at 9:00 am for the regular scheduled meeting. Chair LaFaye Copeland, Vice-Chair Keith Moye, Commissioners June Knight, Ray Prince, Phillip Drew, County Administrator Buddy Johnson, County Clerk John White, Finance Director Holly Murkerson, Executive Assistant Mary Griffin, and Lake Authority Director Mike Binion were in attendance.

The meeting was called to order at 9:00 AM by Chair Copeland. Mrs. Copeland asked County Administrator Johnson to open the meeting with prayer and the pledge of allegiance.

The agenda for the meeting was approved on a motion by Mr. Prince and second by Mr. Drew.

Mrs. Copeland asked for public comments. Mr. Mike Binion was called on as time keeper.
