GRADY COUNTY BOARD OF COMMISSIONERS

MEETING MINUTES

August 18, 2020 Meeting

The Grady County Board of Commissioners met on August 18, 2020 at 6:00 pm for a regular meeting. Commissioners Keith Moye, June Knight, Ray Prince, Phillip Drew, County Administrator Buddy Johnson, County Clerk John White, Financial Director Holly Murkerson, Executive Assistant Mary Griffin, County Attorney Gabe Ridley and Road Superintendent Stanley Elkins were present. Mrs. Copeland was absent from the meeting due to the death of her husband.

Mr. Moye opened the meeting with the Public Hearing for the Abandonment of a portion of Asbell Lane.

Mr. Ridley explained the public hearing was being held in accordance to the ordinance for road abandonment. The portion that is being considered is 1200 ft long by 60 ft wide for a total of about 1.62 acres. The land was deeded to the county in 1995 by Mr. Kenneth Hicks. Mr. Hicks stated there was a mistake in the deed and he asked for the land to be returned in 2020. As best as Mr. Ridley can determine, the property has never been maintained as a road by the county. Mr. Ridley stated that the board must find that that it is in the best interest of the public to abandon the portion of Asbell Lane or that the road is of no benefit to the public. Mr. Ridley stated that if it is decided to abandon the portion of roadway, then it will be offered to Mr. Hicks to see if he would like to purchase the property and if not then it will be sold at public auction.

Mr. Prince stated that there would be an easement for all property owners, and no one would be land locked. Mr. Ridley stated the easement in the original plat would still exist.

Mr. Elkins, Road Superintendent, stated that they have never maintained that portion of the road.

Tommy White, 251 Asbell Lane

Mr. White stated that he would be landlocked on a portion of his property and is satisfied with how it is now. He would prefer to have no one own the land except for the county.

David Dunn, 257 Asbell Lane

Mr. Dunn lives at the end of the proposed section of road that may be abandoned and is in favor of shutting the road down. Mr. Dunn provided pictures of the lane showing it is a grass lane and has never been maintained. Mr. Dunn stated this is only a driveway for his property and he keeps the grass mowed. He stated there is no reason for the public to come down as his property is at the end of the road.

Tommy White, 2nd time

Mr. White stated that Mr. Dunn wants to purchase the property. Mr. White states he has had people tell him he could not use the lane and Mr. White stated he may want to purchase the property.

Mr. Moye stated that the board will not vote tonight but will take the comments under advisement and do more research. Mr. Moye stated a vote would be taken at the meeting on September 1, 2020.

Mr. Moye closed the Public Hearing.

Mr. Moye called the meeting to order at 6:18 pm.

Mr. Moye asked Mr. Ridley to give the invocation and pledge to the flag.

Motion by Mr. Prince, second by Mr. Drew to approve the agenda with the understanding that item C055-20 may be removed after information is provided by Attorney Ridley. The motion was approved.

Public Comments

Richard Jordan, 303 Jordan Rd

Mr. Jordan spoke about the commissioners using the Senior Center building as an administration building. Mr. Jordan stated it is a power grab after the commissioners closed the Senior Center. He stated that we should look after our seniors and if nothing else it should be used as a Social Center.

Holly Stokely, 478 Stewart Rd

Mrs. Stokely stated that she was the director of the Senior Center when it was shut down. She stated that seniors needed a place to go where they can love on each other. Mrs. Stokely feels as if the rental for events and public donations could support the Senior Center.

Mr. Jordan further commented that there is space here at the courthouse that could be used. Mr. Jordan stated we need to look at what is the best use for the building and what is best for our senior citizens.

Mr. Moye pointed out that the commissioners did not close the senior center as Mr. Jordan had stated.

Mr. Johnson stated he met yesterday with Mrs. Nola Daughtry and the Ministerial Association to come up with a plan for our seniors to meet at locate churches for activities. Mr. Johnson also stated that that the Senior Center could still be rented out for events after hours.

Mr. Johnson reported that the new ambulance is in service and Mr. Moye stated the EMS workers were very pleased with it.

Mr. Drew stated that he has training at the end of this week.

Mrs. Knight stated that after talking with Stanley, she would like the county to investigate contracting for the mowing of the right of ways for county roads. Mr. Johnson stated he will get with Stanley and issue an RFP to look at the cost.
