LOST: June 2021 = \$164,500 June 2020 = \$148,700 Up \$15,800






Other news:


2. 2020 Financial audit in process. Auditor expects to present at the August 17, 2021, BOC meeting. Currently awaiting reports from two other offices; he has everything he needs from the Board of Commissioners office.


- 3. 2022 budget requests have been received and entered into CSI. County Administrator and Finance Director are currently reviewing. Tentative reports are to be sent out to each Department Head/Elected Official by July 23, 2021, hopefully. Currently awaiting form PT 32.1 from Tax Commissioner's office to calculate revenue for 2022. We cannot move forward with budgeting until we can calculate revenue. If elected officials desire to present to Commissioners, a budget workshop will need to be scheduled during the week of July 26 30, 2021. No changes to the Budget calendar currently.
- 4. I have attended two different webinars hosted by ACCG/CVIOG regarding the American Rescue Plan Act (ARPA) and have emailed the information to each of you. The theme for the most recent one was "Do Not Rush to Spend ARPA" and to be very strategic. Funds must be obligated by December 31, 2024 (more than three years away) and spent by December 31, 2026 (more than five years away). County governments have been warned to document well how the money is going to be spent and that the treasury may not approve all expenditures as the "Interim Final Rule" could possibly change.
- 5. Finance staff have submitted operational manuals for each task performed in the finance department. I am currently reviewing as time permits.











ACCG is conducting a training on October 5, 2021, in Lee County for LOST negotiations and Redistricting. It is strongly encouraged that all commissioners attend.

FA038-21 Motion by Mrs. Knight, second by Mr. Moye to move the meeting time of the October 5, 2021, meeting to 6:00 pm so the commissioners can attend the training in Lee County. The motion was approved.

Mr. Prince stated that Randy Holton has a subdivision that has now sold all the lots The roads in the subdivision were developed to DOT standards and Mr. Holton is requesting the county take over the roads. Mr. Johnson stated that he will get Mr. Elkins to go and review the roads to ensure they meet DOT standards.

Mrs. Knight stated that the Mower Max and its operator were doing an excellent job mowing the sides of the roads.
