General Fund Expenditures:

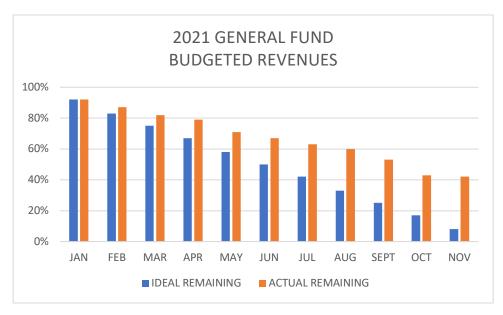

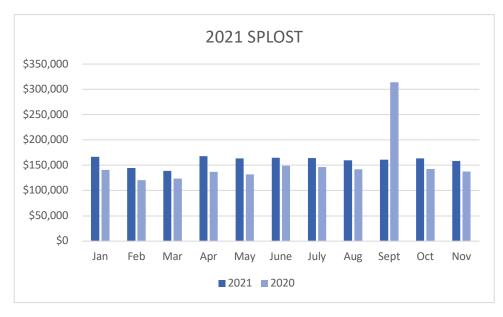
