MEETING MINUTES

November 7, 2023, Meeting

The Grady County Board of Commissioners met on November 7, 2023, at 9:00 am for a regular meeting. Commissioners Ray Prince, Keith Moye, Phillip Drew, LaFaye Copeland, County Administrator Buddy Johnson, County Clerk John White, Finance Director Holly Murkerson, and County Attorney Gabe Ridley were present.

Mr. Drew opened the meeting with a prayer and the pledge to the flag.

Motion by Mr. Moye, second by Mrs. Copeland to approve the agenda as presented. The motion was approved.

Old Growth Forest - Margaret Tyson

Ms. Tyson spoke on the opportunity to designate Wolf Creek Trout Lilly Preserve as an old growth forest. She stated there is no financial obligation for the county.

Jackie Robinson Boys and Girls Club – Stephen Francis

Mr. Francis told the commissioners thanks for their support for the SMART program at the Boys and Girls club. Mr. Francis stated last year was challenging with 120 kids and this year is no different as there are up to 151 kids. Jacameron Spence, who spoke at the Diamond Affair on November 2, 2023, is one of the success stories of the SMART program. He has a goal to go into law enforcement and he stated SMART has assisted him in making good choices in his life.

Audit Report - Perry Henry

Mr. Henry presented the audit for 2022. Issues in the Tax Commissioner's office cause an extension to be filed for completing the office. Mr. Perry stated the county was in very good shape. He stated there were four findings in the audit. 1. Lack of segregation of duties which cannot be corrected due to staffing. 2. The Tax Commissioner's office did not reconcile bank statements in a timely manner. 3. The Tax Commissioner's office failed to transfer funds in a timely manner. 4. The Law Library went over budget.

NEW/UNFINISHED BUSINESS

Mr. Johnson stated that there was one Road Maintenance bid received and it was from North Grady Investments for a total of \$1,350,000.00. The board decided not to go in that direction with that cost.

Mr. Johnson stated there were two bids received for the mowing of the roads. One was from AAA Landscape Management LLC for a total of \$525,000.00 annually. The other bid was from Evergreen Outdoor Services for a total of \$139,000.00 annually.

FA075-23 Motion by Mr. Moye, second by Mr. Prince to engage Evergreen for the roadside mowing. The motion was approved.

The commissioners decided to set a workshop date of 11/14/23 at 5:00 pm to meet with the Paper Please delegation. The commissioners then decided to set a workshop for roads on 12/05/23 at 10:30 am

Mr. Johnson stated that Georgia DOT had requested and received an extension on the Roundabout at 188 and Old Thomasville Road.

Mr. Johnson stated that we may be able to contract out the clipping of the roads, so we are seeking bids on the clipping of the roads.

Mr. Binion reported that the county has satisfied the requirements for monitoring of the mitigation sites so will no longer have to pay for that service.

Mr. Drew stated the oak tree at the courthouse will need to be removed due to it being a hazard.

FA076-23 Motion by Mr. Moye, second by Mr. Prince to seek bids on the removal of the oak tree and seek bids on the replacement of the oak tree. The motion was approved.

Mr. Moye stated that Chief Phillips was seeking bids for a new fire station on Woodland Road.

Mr. Drew recognized Mrs. Copeland had completed all eight tracks of training with ACCG.

Mr. Binion stated that the dam inspection was held last week, and everything was good.

Mr. Elkins stated that they have been awarded the Tire Amnesty Grant again and the date will be January 27, 2024.
