MEETING MINUTES

November 21, 2023, Meeting

The Grady County Board of Commissioners met on November 21, 2023, at 6:00 pm for a regular meeting. Commissioners Ray Prince, Keith Moye, LaFaye Copeland, County Administrator Buddy Johnson, County Clerk John White, Finance Director Holly Murkerson, and County Attorney Gabe Ridley were present. Commissioners Phillip Drew and June Knight participated by telephone.

Mr. Drew requested that Mr. Prince preside over the meetings as Mr. Drew and Mrs. Knight were not in personal attendance. Mr. Prince had Mr. White give the invocation and Pledge to the flag at the 5:00 Budget Hearing so that was not repeated.

Mr. Harrison with the Planning Commission stated most of the Planning Commission wanted the lot size to be 1.5 acres for the entire county. The commissioners told the Planning Commission to submit the requested changes and they would act on the recommendations.
