**Sealed Bids:** Sealed Bids for the construction of the **Pine Park Road, et al. Roadway Resurfacing Phase III** will be received, by **Grady County Board of Commissioners**, at the **33 17th Ave NW, Cairo, GA 39827**, until **11:30 AM, Thursday, March 28, 2024**, local time, at which time the Bids received will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

**Contractor License:** Any Contractor submitting a bid must be a pre-qualified Georgia Department of Transportation Contractor. License numbers must be written on the face of the bid envelope. No bid will be opened unless the license number is clearly shown. See Instructions to Bidders for additional bidding requirements.

**Work to Be Done:** The work to be done shall consist of furnishing all labor, materials and equipment necessary to construct the proposed **Pine Park Road, et al. Roadway Resurfacing Phase III** as shown on the Contract Documents and Specifications. In general, construction consists of widening and resurfacing 1.97 miles of Pine Park Road beginning at end of Phase I and ending at end of Phase II, and 2.26 miles of Singletary Road beginning at Pine Park Road and ending at railroad crossing, including all associated measures for a complete resurfacing project. This work will be awarded in one (1) contract with a **90** consecutive calendar day construction schedule.

Upon request and receipt of the document payment indicated above, Watkins & Associates, LLC will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Engineer. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Office of the Engineer.

**Bonds:** All bid forms must be accompanied by a Bid Bond in an amount not less than ten percent (10%) of the amount bid. The successful bidder, if awarded the Contract, will be required to furnish a Performance Bond and Payment Bond, each in the amount of one hundred percent (100%) of the Contract amount. All bonds must appear on the Treasury Department's most current Circular 570 Listing.
