#### RESOLUTION

### A RESOLUTION DECLARING SASSER ROAD ABANDONED

WHEREAS, on September 17, 2024, the Board of Commissioners certified that Sasser Road has ceased to be used by the public to the extent that no substantial public purpose is served by it and that its removal from the county road system is in the best public interest; and

WHEREAS, on October 15, 2024, a public hearing was held on the proposed abandonment; and

WHEREAS, the sole property owner located thereon was provided with notice of the date and time for the hearing; and

WHEREAS, the Board of Commissioners published notice of the public hearing once per week for two weeks in the Cairo Messenger, which is the newspaper in which the sheriff's advertisements are published for the county; and

WHEREAS, Sasser Road is not part of the state highway system and no part of the road passes through a municipality; and

WHEREAS, the board of commissioners have followed the procedures for abandonment as set out in O.C.G.A. § 32-7-2.

NOW THEREFORE, after study and investigation, and after having considered the testimony and evidence presented at the hearing, and after having heard no objections from any member of the public, BE IT RESOLVED that:

Grady County, acting by and through its board of commissioners, does declare that the county-maintained road known as Sasser Road, which is situated in Land Lots 237, 238, 239, and 202 of the 19th Land District, Grady County, as shown on that plat of survey by Larry Burnsed, Georgia Registered Land Surveyor, dated July 15, 2024, and recorded in plat book E2024, page 74, in the property records of Grady County, is hereby abandoned.

The road shall no longer be part of the county road system and the rights of the public in and to the section of road as a public road shall cease according to O.C.G.A. § 32-7-2.

Grady County shall not be responsible for any further maintenance or repairs to the road.

It appearing that there is no recorded conveyance granting Grady County title to the lands comprising the right-of-way, the county does disclaim any right, title, or interest in and to those lands that it may have acquired by prescription.
